About Us

Friends of Glen Fern Valley Bushlands are a 'Friends Of community group dedicated to the conservation and enhancement of the 100 acre area of land in the Lysterfield Valley bounded by New Road, Glenfern Road and Ferny Creek.

Friends of Glen Fern Valley began when Serg Zaccaria and Sarah Tebbutt held a public meeting on the 26th September 2001. Over 100 people attended this meeting, and many present expressed interest in doing all they could to ensure this land was preserved for the appropriate use and enjoyment of all. Out of this initial energy and enthusiasm was born a group committed to the land we call Glen Fern Valley Bushlands. The group now has over 200 people on its mailing list and over 50 paid up members and is growing steadily.

Our Aims

Presently the land is 'unreserved' Crown Land, managed by the Department of Natural Resources and the Environment (DNRE). That means it is not safe from inappropriate uses and development. The 'Friends Of group is working to ensure the land is made safe from such things. The only way to do this is to have the land reserved for the enjoyment of all as a bushland Reserve. As a Reserve, the land would need a Committee of Management. The 'Friends Of group, although very keen and active, does not have the resources to take on the management of such Reserve. Our aims then are:

- To have the land reserved
- To establish a joint Committee of Management between the Shire of Yarra Ranges, DNRE and Melbourne Water
- To conserve the land, encouraging natural regeneration where possible

What's been happening?

- In March 2002 we finally became incorporated. This means that we are now
 officially recognised as a 'Friends Of' group. Also we can now hold a bank
 account, & have 50 fully paid members.
- Our last community Planning and Information Day was a fantastic success with approximately 100 people attending. We are looking forward to continuing support at the Public Working days on the site.
- On 8th April a small delegation met with officials from DNRE. (Department of Natural Resources & Environment). Unfortunately the representative that we were hoping to meet was called away so we were not able to put a submission as planned, however we were invited to arrange a further meeting with them. This may lead to a possible meeting with the Environment minister in the near future. The lobbying is continuing!!!
- Both our flora and fauna group have been very busy surveying the plant and animal life in the reserve. So far the flora group has identified approx 105 native species and 50 weed species. This is still a work in progress.

The fauna group has identified 76 species of bird, including the brush bronzewing. Koalas, wallabies, and signs of wombat activity have also been found.

These surveys have been invaluable in determining how best to control unwanted non-indigenous plants, and help us plan the best way of revegetating and regenerating the land whilst keeping the impact on the native flora and fauna to a minimum.

 Some people have asked why we have not held a large scale working bee to remove as much of the blackberry, bone seed and other weeds as possible?

The answer is that to remove large areas of vegetation may destroy wildlife habitat, look unsightly, can create erosion, and may encourage further weed growth. We are hoping to operate using an established system that prescribes weed removal in small non-adjoining areas.

Once all surveys have been completed and analysed a structured program that members can participate in will be arranged so that the year will be planned according to the best times for weed removal of each type with as little impact on the wildlife as possible.
